WHEREAS, on 16 March 2022, Executive Director (ED) Jocelyn Alma R. Badiola, as Head of Procuring Entity (HoPE), approved the memorandum request for the approval of procuring plaques for the 2nd Gawad Sa Paglingap Sa Magsasaka at Mangingisda (Gawad Lingap Awards);

WHEREAS, with an Approved Budget for the Contract (ABC) of One Hundred Ninety-Eight Thousand Pesos (PhP 198,000.00), the “Procurement of Plaques for the 2nd Gawad Sa Paglingap Sa Magsasaka at Mangingisda (Gawad Lingap Awards)” will be acquired pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
