WHEREAS, on 21 April 2022, Executive Director (ED) Jocelyn Alma R. Badiola, as Head of Procuring Entity (HoPE), approved the purchase request for the Procurement of Twenty-Three (23) Wireless Keyboard and Mouse Combo;

WHEREAS, with an Approved Budget for the Contract (ABC) of Forty-Six Thousand Pesos (PhP 46,000.00), the "Procurement of Twenty-Three (23) Wireless Keyboard and Mouse Combo" will be acquired pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
