WHEREAS, on 21 April 2022, Executive Director (ED) Jocelyn Alma R. Badiola, as Head of Procuring Entity (HoPE), approved the purchase request for the Procurement of Twenty-Three (23) Units USB Hub;

WHEREAS, with an Approved Budget for the Contract (ABC) of Twenty-Four Thousand Pesos (PhP 24,000.00), the "Procurement of Twenty-Three (23) Units USB Hub" will be acquired pursuant to Section 53.9 (Small Value Procurement) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

WHEREAS, the BAC, thru its Secretariat, posted the Request for Quotation on April 27, 2022 at the Philippine Government Electronic Procurement System (PhilGEPS) and set the deadline of submission of bids on May 4, 2022 and received two (2) price quotations, namely:
