BAC RESOLUTION NO. 3 Series of 2021

“RESOLUTION AWARDING THE CONTRACT FOR THE SUPPLY AND DELIVERY OF DESKTOP AND LAPTOP COMPUTERS under ITB 2021-01”

WHEREAS, the Agricultural Credit Policy Council (ACPC) advertised the Request for Expression of Interest for the “**Supply and Delivery of Desktop and Laptop Computers**” under ITB 2021-01 with an Approved Budget for the Contract (ABC) amounting to **Three Million One Hundred Forty Thousand Pesos (PhP 3,140,000.00)** at the Philippine Government Electronic Procurement System (PhilGEPS) from April 26 to May 4, 2021;

WHEREAS, a Pre-Bid Conference was conducted on May 3, 2021, attended by representatives from Quartz Business Products Corporation, Integrated Computer Systems, Inc., DCI International Solutions and Services Corporation, E-Partners Solution, S1 Technologies, Inc. and Advance Solutions, Inc.;

WHEREAS, only one (1) prospective bidder responded to the invitation and submitted their eligibility documents on May 17, 2021, namely;

1. DCI International Solutions and Services Corporation

WHEREAS, the DCI International Solutions and Services Corporation only submitted bids for Lot 1, Lot 3 and Lot 4 amounting to PhP 2, 542,000.00.

WHEREAS, pursuant to Section 32 Rule IX of the 2016 Revised Implementing Rules and Regulations of the Republic Act 9184, the bid proposal of DCI International Solutions and Services Corporation was subjected to detailed bid evaluation;

WHEREAS, after the evaluation of DCI International Solutions and Services Corporation’s eligibility and its compliance to the technical specifications required by the procurement project, the ISMD (end-user), through its memorandum dated May 24, 2021, recommended DCI International Solutions and Services Corporation;

WHEREAS, the TWG, upon completing the evaluation of DCI International Solutions and Services Corporation’s eligibility and technical and financial proposals, found the bid of DCI International Solutions and Services Corporation to be complete and without any computational nor arithmetical errors, pursuant to Sec. 34 Rule X of the 2016 Revised IRR of RA 9184, thus it recommended that its bid be identified and declared as Single Calculated Bid and be subjected to Post-Qualification;

WHEREAS, the BAC adopted the recommendation of the TWG to identify DCI International Solutions and Services Corporation as the Single Calculated Bid for the project and to subject the said bidder to Post-Qualification;

WHEREAS, DCI International Solutions and Services Corporation was accordingly informed of BAC's findings, and was required to submit the post-qualification documents such as Business Permits, Tax Clearance, Latest Income and Business Tax Return and other pertinent documents;

WHEREAS, the TWG conducted the Post-Qualification on June 8, 2021 in accordance with Section 34 of the Revised IRR of RA 9184 by validating, verifying, and ascertaining the authenticity of the documents submitted by the bidder and the veracity of the statements contained in those documents;

WHEREAS, after verifying and validating that the documents submitted by DCI International Solutions and Services Corporation are authentic, in order and contained true and accurate statements or information, the TWG recommended to the Bids and Awards Committee (BAC) that the DCI International Solutions and Services Corporation be declared as the Single Calculated and Responsive Bid (SCRB). The TWG also recommended that the contract for the "Supply and Delivery of Desktop and Laptop Computers" be awarded to DCI International Solutions and Services Corporation;

WHEREAS, the BAC adopted the recommendation of the TWG contained in its memorandum dated on June 14, 2021 to declare the bid of DCI International Solutions and Services Corporation as the Single Calculated and Responsive Bid (SCRB) and to award the contract to the said bidder;

WHEREAS, based on the result of the Bid Evaluation and Post-Qualification, the BAC finds that the bid of DCI International Solutions and Services Corporation is compliant and responsive to all the requirements and conditions in the bidding documents and has the capability to undertake the project;

THEREFORE, BE IT RESOLVED AS IT HEREBY RESOLVED, to declare the bid of DCI International Solutions and Services Corporation as the Single Calculated and Responsive Bid (SCRB) and to recommend to the Head of the Procuring Entity (HOPE) that the project amounting to PhP 2, 542,000.00 for Lots 1, 3 and 4 be awarded to DCI International Solutions and Services Corporation.

RESOLVED FURTHER that the remaining Lot 2, wherein no bid has been submitted, be posted as Request For Quotation under Small Value Procurement.


